EFAA AND BROOMFIELD FISH COLLABORATE TO TRANSITION BASIC NEEDS SAFETY-NET SERVICES FOR BROOMFIELD RESIDENTS TO FISH IN 2017

Broomfield's growth puts FISH in a strong position to expand services, with EFAA providing support throughout 2016 for a smooth transition.

March 30, 2016, BROOMFIELD, CO – Given the recent growth of both Broomfield and Boulder Counties, as well as the increasing number of local families living in poverty, Emergency Family Assistance Association (EFAA) and Broomfield FISH have embarked on a year-long collaboration to transition more basic needs safety-net services for Broomfield's low-income residents to FISH starting January 1, 2017. Throughout 2016, EFAA will continue to provide basic needs services, such as rent and utility bill assistance to Broomfield residents, while working closely with FISH as they expand their services to meet local needs.

"For more than fifty years, FISH has been instrumental in understanding and responding to the unique needs of Broomfield's growing community," says Dayna Scott, Executive Director of FISH. "Currently, we serve more than 4,000 unduplicated residents annually and we are in a strong position to expand so we can accommodate those Broomfield clients who currently work with EFAA. FISH is well-known as a food pantry, but we also provide some level of emergency utility, transportation, and medical assistance to residents in need. In the next five years, our goal is to become a thriving family resource center, so this transition is a logical next step for both organizations."

With this collaborative transition, FISH can focus on building services and capacity locally, and EFAA can continue to focus its resources on addressing family homelessness and intergenerational poverty in Boulder County, a key goal of EFAA's five-year strategic plan. Also, with FISH supporting the safety-net needs in Broomfield County and EFAA supporting the safety-net needs in Boulder County, any duplication of services will be avoided.

"The timing is right," says Julie Van Domelen, EFAA's Executive Director. "FISH has grown into a vital local resource and we will work closely with them to ensure a smooth transition, including providing them with institutional support and capacity building assistance."

In the past, EFAA has successfully implemented similar transitions with other sister agencies, like Sister Carmen in Lafayette and OUR Center in Longmont.

EFAA will continue to provide access to EFAA's Short-Term and Transitional housing located in Boulder County for eligible Broomfield homeless families until Broomfield County is able to provide those services locally, or mid-2018 at the latest.
