What to Bring with you

CRC

Personal information

- Last year's taxes (both your federal and state return)
- Social Security numbers for yourself, your spouse and all dependents
- Bank account number and routing number

Income

- W-2 forms
- 1099 forms
- 6252 forms
- Miscellaneous income (jury duty, gambling winnings, Medical Savings Account, scholarships, etc.)
- Alimony received Business
- Farming income profit/loss statement
- Capital equipment information
- Rental property income and expenses profit/loss statement
- Suspended loss information
- Prior year installment sale information
- Principal and interest collected during the year

Deductions

- Retirement account contributions.
- Educational expenses.
- Medical bills.
- Property taxes and mortgage interest.
- Charitable donations.
- Classroom expenses. If you're a school teacher or other eligible educator
- State and local taxes.
